Purpose of the course: This is an undergraduate course intended to introduce students to the central economic issues in international politics and some of the fundamental models that we use to understand them. The course covers a series of topics ranging from trade and development to international finance. No previous coursework is assumed.

Course Requirements: The required readings are assigned to the lectures for which they provide background, and will be discussed in the subsequent discussion section. There will be a final exam (Tuesday, May 8, at 12:30) and two exams during the term, on February 21 and April 4. Attendance at lectures and discussion sections is mandatory. Each student is allowed to miss up to three class sessions for personal reasons, but missing more results in a penalty, and missing more than five results in a failing grade.

<u>Grading</u>: 40% final exam, 25% each exam, and 10% class participation. Completing all of the written work is required to successfully complete the course.
