PSC 244K/W—Politics and Markets: Innovation and the Global Business Environment This Version: November 18, 2016

Course Description

Innovation is a driving force behind the massive increases in wealth that occurred in the 20th century, and the globalization of business is causing changes in the world's economy that we are only beginning to understand. In this course, we will spend several weeks studying how entrepreneurship and innovation are affected by government institutions. We will then spend several weeks studying business strategy in the global business environment, focusing on the role of regulations imposed by foreign governments and international organizations. Class meetings will be a mix of lecture and discussion, use real-world cases, and feature guest speakers. By the end of the course, you will have a stronger understanding of how businesses shape and are shaped by government policies. There are no prerequisites for this course, though some exposure to political science or economics is useful.

Readings

There is one required textbook for the course: *Business and Its Environment*, 7th ed., by David P. Baron. Two copies of the textbook are on 2-hour reserve in Rush Rhees Library. Additional required readings will be available in the Reserves section of the course Blackboard page at least one week prior to the course meeting during which they will be discussed. The textbook reading for the Sept. 15 class is also available in the Reserves section of Blackboard for those students who are not able to acquire a textbook immediately.

Course Requirements

- *Analysis Questions:* For certain classes, indicated by "HW Due" on the syllabus, you will be asked to analyze a case or answer questions about a set of readings. Questions will be available in the Assignments section of Blackboard at least one week prior to the due date. In order to receive credit, all questions must be answered and the write-up must demonstrate careful consideration of the case/readings. Assignments are due at the beginning of class on the day the case or topic is discussed. *Late assignments will not be accepted*.
- 244W Students—Course Paper: PSC 244W students will be required to turn in a 3,500-word paper on a topic related to innovation or the global business environment. Topics must be submitted by October 13, and the paper will be due on December 6; details are on Blackboard under Syllabus. No late papers will be accepted.

Grading

- *Exams* each count toward *30 percent* of your grade.
- Analysis Questions collectively count toward 10 percent of your grade. You are required to turn in 6 assignments to receive full credit for this portion of your grade. If you turn in fewer than 6 assignments, your grade will be reduced proportionally. For instance, if you turn in only 5 assignments, you will receive 8.3 out of 10 points for this portion of your grade. Turning in more than 6 assignments will not increase your grade, but I encourage you to do all assignments in order to be better prepared for class and for exams.
