## **PSCI 244K: Politics and Markets: Innovation and the Global Business Environment Version 5 (April 21, 2021)**

### **COURSE DESCRIPTION**

Innovation is a driving force behind the massive increases in wealth that occurred in the 20th century, and globalization is causing changes in the world's economy that we are only beginning to understand. In this course, we will spend several weeks studying how entrepreneurship and innovation are affected by government institutions. We will then spend several weeks studying business strategy in the global business environment, focusing on the role of regulations imposed by foreign governments and international organizations. Class meetings will be a mix of lecture and discussion, use real-world cases, and feature guest speakers. By the end of the course, you will have a stronger understanding of how businesses shape and are shaped by government policies. There are no prerequisites for this course, though some exposure to political science or economics is useful.

### **LEARNING MODULES**

To match the mode of instruction in Spring 2021, PSCI 244K is structured as a set of learning modules. For each topic, there will be preparation materials such as pre-class readings and videos. Within each learning module, you will find all of the readings, assignments, and expectations for the week. Professor Primo's goal in designing the course this way is to provide a structure for the course's workload that is linear, logical, and user-friendly, and that the result will be productive class sessions and a positive overall course experience.

### **COURSE MATERIALS**

There is one required textbook for the course: *Business and Its Environment*, 7<sup>th</sup> ed., by David P. Baron. Additional required course materials will be made available on Blackboard at least one week prior to the associated class meeting.

### **COURSE REQUIREMENTS**

- **Exams:** There will be two open-book exams in the course (permitted materials will be discussed prior to the first exam). The first exam will go live at 11:05 AM on Tuesday, March 16, and the second exam will go live at 11:05 AM on Thursday, May 6. Because you will have approximately 24 hours to complete the exam and it is designed to be completed in about 2-to-4 hours, make-up exams will not be given—exceptions are rarely granted.
- **Pre-Class Preparation (PCP) Assignments:** Each learning module not featuring a guest speaker will include a short pre-class preparation assignment. The purpose of the PCP assignments (and GSQ assignments—see below) is to (a) provide an incentive for you to do the pre-class work and come to class prepared and (b) upweight low-stakes assessments in your final course grade. You will be assessed based on the highest 9 of your PCP assignment scores, but you are encouraged to complete all assignments. Late assignments will not be accepted.
- **Guest Speaker Questions (GSQ) Assignments:** In advance of classes featuring a guest speaker, you will be asked to submit a question for the speaker along with a brief explanation for what aspect of the pre-class preparation sparked that question. You will be assessed based on the highest 4 of your GSQ assignment scores, but you are encouraged to complete all assignments. Late assignments will not be accepted.
- **Independent Reading:** Students are expected to spend 50 minutes outside of class each week reading the *New York Times*, *Wall Street Journal*, or other reputable news source in order to deepen their understanding of how the themes of the course relate to current policy issues. All University of Rochester students are eligible for free access to the online version of the *Wall Street Journal*; see <https://wsj.com/rochester> for details. Students will have an opportunity to share interesting articles relevant to the course during the semester.

### **SUBMITTING ASSIGNMENTS AND EXAMS**

All exams and assignments will be completed and submitted on Blackboard—no attachments. Simply follow the links for each assignment and exam and the rest should be straightforward. Students are encouraged to save their work frequently.

## **GRADING**

- Each *exam* counts toward 30 *percent* of your course grade.
- *PCP Assignments* collectively count toward 30 *percent* of your course grade. They are graded out of 10 points. Your highest 9 scores are counted toward your course grade.
- *Guest Speaker Questions* collectively count toward 10 *percent* of your course grade. These assignments are graded out of 10 points on a high-pass/pass/no-credit basis, equivalent to 10, 6, and 0. The expectation is that any student submitting a question and associated explanation demonstrating that they have done the pre-class preparation will receive 10 points for that assignment. Your highest 4 scores are counted toward your course grade.
- *All exams and assignments should be completed independently.*

## **TEACHING ASSISTANTS**

There are two teaching assistants in the course: Theu Dinh (tdinh5@ur.rochester.edu) and Fred Gui (pGui@ur.rochester.edu). They will be grading the assignments and exams, with Prof. Primo's guidance. Students may also email the either of the TAs with questions about the course material.
